ORDER

As per the Government Order read as first paper above, basic pay limit for the benefit of Exgratia allowance under Rule 90-A, Part I, the KSRs has been enhanced from Rs. 42,500/- to Rs. 68,700/- subject to a maximum of Rs. 24,045/- and a minimum of Rs. 13740/- per mensem.

As per the Government Order read as second paper above, Government have revised the scale of pay of state government employees with effect from 01.07.2019. Pursuant to the pay revision, the monetary limits in Rule 90-A, 93, 103 of Part I and Appendix VII of the Kerala Service Rules have to be revised. Accordingly, Government are pleased to order as follows:

- (i). In clause (a) of Rule 90-A, the limit of Rs. 68,700/-, Rs. 24,045/-, Rs. 13,740/- will be enhanced to Rs. 95,600/-, Rs. 33,460/-, Rs. 19,120/- respectively.
- (ii). In the Exception below Rule 93, the limit of Rs. 35,700/- will be enhanced to Rs. 50,200/-
- (iii). In clause (b) of Rule 103, the limit of Rs. 27,800/- will be enhanced to Rs. 39,300/-
- (iv). In clause (i) of Rule 1 under section II of Appendix VII, the limit of Rs. 30,700/- will be enhanced to Rs. 43,400/-

The above orders shall have retrospective effect from 01.07.2019.

Formal amendments to the Kerala Service Rules will be issued separately.


