S. R. O. No. 767/2023 In exercise of the powers conferred by sub-section (1) of section 2 of the Public Services 1968 (19 of 1968), read with Kerala Act, section 3 thereof. the Government of Kerala hereby make the following rules further to amend the Kerala State and Subordinate Services Rules, 1958, namely:----

RULES

1. *Short title and commencement.*— (a) These rules may be called the Kerala State and Subordinate Services (Amendment) Rules, 2023.



(b) They shall come into force at once.

2. *Amendment of the rules.*— In Part II of the Kerala State and Subordinate Services Rules, 1958, in rule 27, for the 4th proviso to sub rule (c), the following proviso shall be substituted namely:—

" Provided also that the seniority of a person appointed or advised for appointment in one service from a common selective list, prepared by the Commission and thereafter discharged from service or denied appointment, as the case may be, for want of vacancy and got reappointed in another service or another Department/Institution on further advice of the Commission, shall be determined by the date of his first advice."

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the 4th proviso to sub rule (c) of rule 27 under Part II of the Kerala State and Subordinate Services Rules, 1958, the seniority of a person appointed in one service from a common selective list, prepared by the Commission and thereafter discharged from service for want of vacancy and got reappointed in another service or another Department/Institution on further advice of the Commission, shall be determined by the date of first effective advice. But, on considering situations of denial of appointment for want of vacancy, after getting advice memo from the Kerala Public Service Commission, Government have decided to retain the seniority of such candidates also, who have not received an appointment order after getting an advice memo, from the date of their first advice. Now the Government have decided to make amendment to the 4th proviso to sub rule (c) of rule 27.

The notification is intended to achieve the above object.
