ORDER

As per the existing orders inter–district transfers of Government employees will be allowed only after completion of five years service in the district of recruitment.

It has been found that there is dearth of employees, particularly teachers, in Idukki Wayanad and Kasargod districts . At the same time there are several candidates who are willing to go even to there districts from other districts. But as they are not having the required minimum service of five years they can not be allowed inter – district transfers as per the existing rules.

Government have considered the question of clearing the five year restriction for transfers of teachers to these districts and took up the matter twice with the Public Service Commission . The commission, however, did not agree to the proposal .

Having examined the matter Government, over ruling the advice or the Public Service Commission, order that Government Servants (including Teachers) recruited in other districts will be permitted to be transferred to the Districts of Idukki, Wayanad and Kasargod without insisting on completion of five years service in the original districts of recruitment . This concession will be available only for getting transfer into these districts. It is further ordered that this concession will to granted only once in the career of a Government Servant.
